1. TRIP ITINERARY: Trips are quoted based on a predetermined number of hours for which you have been contracted. It is your responsibility to manage the trip times, stop to stop. Contracted time starts when you step foot onboard the bus and continues till every person has exited the bus at the final destination. VIP Rides will allow a 15 min grace period for trips running over their contracted time. Once this time reaches in excess of 30 minutes you agree to pay \$50 per every 30 minutes that trip goes over the contracted time.
2. TRIP ERRORS: Occasionally a trip will be detoured or delayed for conditions inadvertent or beyond our control such as traffic, weather, missing a turn necessitating taking an alternate route or many other reasons. As well, we reserve the right to make the occasional human error. Detours or delays not due to customer causes (wrong directions, for example) longer than 15 minutes will be compensated only with time added to the end of the trip.
3. LOST OR STOLEN ITEMS: VIP Rides LLC is not responsible for any lost or stolen items.
4. ILLEGAL STUFF: We cannot permit any illegal activities including but not limited to illegal drugs, underage drinking, public intoxication, or disorderly conduct. **The driver will have sole discretion in these matters and may terminate the trip at any time should he deem it necessary. There will be no refund if the trip is terminated for breach of this contract.**
5. DEPOSIT: We require that you make a **non-refundable** deposit of \$200 at reservation time to hold your date. **Dates are not guaranteed until this deposit has been paid.** The remaining balance should be paid four days prior to date of event unless late payment permission given.
6. CANCELLATIONS: You must Cancel 14 days prior to your trip to avoid a cancellation fee. Cancellations less than 14 days prior to your contracted date will be charged an additional fee of \$200.00.
7. OVERTIME: If your trip time runs over the contracted amount, you agree to permit the overtime charges to be billed to your credit card or paid in cash in the amount of \$50 per 30 Minutes. Drivers will attempt to collect for overtime charges BEFORE they are incurred either in cash or by credit card. If driver cannot collect, you agree that overtime charges will be charged to your credit card that we have on file.
8. SUBSTITUTE VEHICLE: We reserve the right to substitute vehicles when unforeseen circumstances make it necessary. We will, of course, notify you and make necessary price adjustments, if applicable.
9. BEHAVIOR: You agree to be responsible for the behavior of all persons on the bus and for all damages to our vehicles and/or property due to their activities. This includes
 1. a "trashed" vehicle- excessively soiled with dirt, beverage spills, body fluids, food or beer cans. A "trashed" vehicle will incur a **\$150.00** Cleaning charge.
 2. **Additional charges will be levied for: Broken fixtures\$200, torn or burnt seats\$250, or other damage \$200. If our vehicle incurs down time for repairs and consequent lost revenue, you agree to be responsible for such lost revenue and to permit such charges to be charged to your credit card.***
10. PROMS/HOMECOMINGS: Must be contracted for by parent only. No student will be permitted to contract for these events.
11. DISORDERLY CONDUCT: Disorderly conduct or conduct in the judgment of the driver that hampers trip safety or jeopardizes property or persons either on or off the vehicle may be grounds for termination of the trip. We reserve the right to eject individuals from the vehicle and will do so at the sole discretion of the driver or VIP RIDES management. In such a case, the person or persons jeopardizing the trip will be dropped off at the nearest safe facility such as a police station, gas station, restaurant or the like. You agree to be fully responsible for those individuals and to hold VIP RIDES harmless for any liability or action arising out of the ejection of party members from the vehicle for any cause whatsoever.
12. INSURANCE: VIP RIDES is dedicated to providing the safest environment for our clients and is fully insured in the state of Ohio. Please remember that you are on a moving vehicle and to always remain seated while the bus is in motion. VIP Rides is not liable for persons who get injured due to unsafe activities. **DO NOT STAND ON THE SEATS. DO NOT HANG OUT THE WINDOWS.** Our insurance coverage stops the moment your foot touches the ground as you step off the bus. Please be aware of this, as any claims for injury, loss, or other claim away from the bus must be covered by individual insurance or the facility where such loss or claim occurred.
13. DISPUTES: By acceptance of the products/services included on this agreement, you agree that all disputes between the parties, or arising from the relationship between the parties, and all disputes arising from or related to the products/services included in this agreement, including the scope of this arbitration agreement, shall be resolved by binding arbitration by the National Arbitration Forum, under the Code of Procedure then in effect. Any award of the arbitrator(s) may be entered as a judgment in any court having jurisdiction. In the event a court having jurisdiction finds any portion of this agreement unenforceable, that portion shall not be effective and the remainder of the agreement shall remain effective.
14. APPLICABLE LAW: You agree that this agreement shall be arbitrated or litigated under the laws of the State of Ohio and that any and all litigation shall be prosecuted in Summit County, Ohio.
15. CREDIT CARD CHARGES: By your signature on this agreement (either electronic, facsimile or original) you consent to charges on your credit card as outlined in this agreement. Your signature below or on page one of the User Agreement constitutes our "signature-on-file" for credit card transactions and you hereby agree to same.
16. NOT ALLOWED ON BOARD: Jello Shots, Funnels, Illegal Drugs, Drug paraphernalia, and Weapons, are not permitted on our buses.
17. VIP Rides LLC reserves the right to cancel any trip at any time for any reason we see fit.
